ELIGIBILITY REQUIREMENTS

- Companies must have revenue of at least \$350,000 in each of the fiscal years ending 2023, 2024 & 2025.
- Companies must show revenue growth in 2025, as compared to 2023 (a two-year period).
- Companies must be headquartered in Rock Island, Henry and Mercer counties in Illinois and Scott, Clinton and Muscatine counties in Iowa.
- Companies must be for-profit entities.
- Companies must submit the completed nomination form and a compiled, reviewed or audited financial statement or a tax return (first 4 pages of income tax returns). No general ledger information needed. **No financial information will be printed and all will be kept confidential. Actual revenue amounts will not be published.**
